## VFAA/SHAC Gallery - *Gifts of Art* Art Exhibition and Sale *October 31 - December 29, 2018*

VFAA and the SHAC invite you to participate in our holiday season art show, ***Gifts of Art***. The theme of this show is designed to encourage our visitors to enjoy and perhaps GIVE gifts of art this holiday season. For this show, we are looking for small, affordable works of art, suitable for gift-giving. Also, we will have three events happening during this show, so there will be three more opportunities to sell your work!

***You are invited*** to bring up to 4 pieces of art. The artwork you enter must be your own original creation in its original form. Please no giclees or other types of prints (see below for entry of cards and prints.) The maximum dimension of the framed art should be no larger than 17", and the maximum price not more than \$150.00. If, during the show, a piece of your work sells, you are welcome to bring in another piece (meeting the same requirements) to replace it.

***New this year - cards, prints and table-top art!*** We will have a separate area for display and sale of cards, unframed prints and table-top artwork. Artists can bring in a maximum of 10 cards and 5 unframed art prints. Cards and prints must be enclosed in plastic sleeves or shrink wrap. Artists may also bring up to 4 table-top items. We will have several tables set out for any items that need table space to display. Please label each card, print or table-top item with your name and price, and fill out the attached forms.

**Entry Procedure:** Bring your art to the SHAC **October 24 - 30**. It can be old or new art. It must be framed and ready for display. You are already juried in if you are a VFAA member. Non-members are welcome to participate for a \$40 entry fee which will cover their membership through 2019. Art will not be juried out of the show unless we end up with more art than wall space. The Gallery Committee does reserve the right to refuse a piece that it deems inappropriate for this show or venue for any reason.

- **Fill out the entry forms and liability statements** attached. (Entry forms are on hand at the SHAC as well.)
- **Use the labels** at the bottom of the form to identify your art.
- **Bring your art** (with payment if necessary) wired and ready to hang - no sawtooth hangers - to the SHAC anytime during the week of **October 24 - 30**, during office hours:  
Mon. 10 - 1; Tues 10 - 6; Weds - Sat 10 - 2.
- **Sign in at the SHAC** so we have a record of whose art we have.
- **VFAA/SHAC will take a 25% commission fee**, so price your work accordingly, or mark NFS. If you do not include a price, we will mark the work NFS.
- **The Artists Reception is Saturday, December 8, 7:00 - 8:30 pm**. Please bring a finger-food dish to share.
- **Pick up unsold art** after the show ends - from **January 2 - 8**.
